

ELEVATE ENTERTAINMENT GROUP – AUSTIN FC VS. REAL SALT LAKE 09/28/2024 MATCH TICKET GIVEAWAY

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN

ELIGIBILITY: The Elevate Entertainment Group Austin FC 9/28 Social Media VIP Ticket Giveaway (“Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius of Q2 Stadium located at 10414 McKalla Place, Austin, Texas 78758 (“Stadium”), plus to the extent not included in the foregoing, the geographic area included within the corporate limits of the City of San Antonio, Texas and the City of San Marcos, Texas (“Territory”) and who are at least 18 years old at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child, and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Austin TeamCo LLC d/b/a Austin FC (“Austin FC”), Major League Soccer, L.L.C. (“MLS”), Soccer United Marketing, LLC (“SUM”), Pro Soccer Development, LP (“MLSNP”), and Player Development, LLC (“PDEV” and together with Austin FC, MLS, SUM, and MLSNP, collectively, the “MLS Entities”), Elevate Entertainment Group (“Elevate” or “Sponsor”), and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a Prize. This Sweepstakes is in no way sponsored, endorsed, or administered by or associated with Facebook, Twitter, or Instagram. The Sweepstakes is subject to all applicable federal, state, and local laws, rules, and regulations. Void outside Territory, and where prohibited or restricted by law, rule, or regulation.

PRIZE: One (1) Winner will receive: four (4) tickets and an on-field experience to the Saturday, September 28, 2024 Austin FC vs. Real Salt Lake game at Q2 Stadium, 10414 McKalla Place, Austin, Texas 78758 (“Prize”).

A total of one (1) Prize is available to be awarded. The Approximate Retail Value of the Prize is \$500. The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein, in addition to all Prize details, are at Sponsor’s sole discretion.

Winner agrees to accept the prize “as is.” The Prize is non-transferable and non-assignable, with no cash redemptions or substitutions except at Sponsor’s sole and absolute discretion. HOW TO ENTER: The entry period for the Sweepstakes begins on **September 10, 2024 at 12:00 pm CT** and ends on **September 16, 2024 at 11:59 pm CT** (“Entry Period”). During the Entry Period, any entrant who satisfies the eligibility requirements set forth herein will be eligible to enter the Sweepstakes to win the Prize by completing the following actions:

To enter, entrants must visit <https://www.elevategroup.com/austinfctickets> and enter their name, valid email address, zip code, and phone number, and may consent to receive advertising e-mail messages from Sponsor (optional) (each an “Entry”; collectively, “Entries”). All entries must be received by September 16, 2024, at 11:59:59 p.m. CT. Limit one (1) Sweepstakes Entry per person. Proof of entry submission is not proof of receipt. Standard internet access fees apply.

NOTIFICATION: Sponsor will notify each Winner by phone and/or email. In the event that any Winner does not respond to any such notification within one (1) day of the date of issuance, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be chosen from among all remaining eligible entries.
